Charlotte Jewish Preschool Financial Policies

Upon acceptance to the Charlotte Jewish Preschool's 2019-2020 preschool program, I understand the following financial terms:

- A \$140 non-refundable registration fee is due upon registration. There is an additional \$70 non-refundable registration fee for each additional sibling.
- CJP sets forth an annual tuition rate that allows families to make equal monthly payments (11 for Full Day/TK and 9 for Half Day).
 - Regularly scheduled monthly tuition payments are July through May for Full Day and TK programs, and August through April for Half Day programs.
 - The first payment represents a one month tuition deposit that will be utilized for my child's last month's tuition (May 2020 for Half Day and June 2020 for Full Day).
 - For new families & TK families, this tuition deposit will be due April 1, 2019
- The tuition deposit is non-refundable unless I provided a 30 day written notice and I am relocating a distance greater than 50 miles from Shalom Park.
- If I do not enroll in Tuition Express, and my tuition is not received by the 10th of the month, a late fee of \$25 will be automatically charged to my account.
- I can enroll in Tuition Express and have tuition payments paid by Electronic Fund Transfer (EFT) either as an ACH debit from a checking account (no monthly fee) or by an ACH credit card draft (\$15 convenience fee per month, per child). I will have the option to have tuition drafted on the 1st or the 10th of the month. All outstanding balances will be drafted with tuition.
- Rejected tuition drafts may be subject to a transaction fee.
- Tuition credits will not be given for voluntary absences.

I understand and agree to the above terms and conditions. I understand that if I require an extended payment plan, I will contact the CJP Finance Manager to make payment arrangements. I understand, as per the CJP Family Handbook, that non-payment of tuition will result in termination of services.
